1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2023-24 was £9.93 per elector.

In 2023-24, the Council made payments totalling £120.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

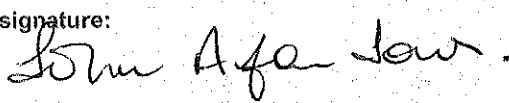
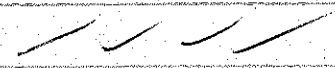
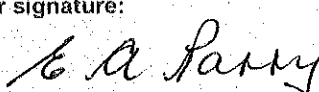

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Llanfaethlu and Llanfwrog Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Accounting Statement

I am unable to conclude whether or not the Accounting Statement properly presents the Council's receipts and payments and financial position:

- As noted in the Internal Audit report, not all payments were supported by appropriate documentation, and there was no clear audit trail to demonstrate that payments had been properly approved and duly recorded by the Council.
- The Council has not provided a full and quantified explanation of variances between the current and prior years' accounts.
- The Council has not provided a properly completed bank reconciliation as at 31 March 2024.

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

Assertion 1: Approval of the accounting statements

- The Council does not publish its minutes online; as a result, there is insufficient evidence to confirm that the accounting statements and the Annual Governance Statement were formally approved by the Council.

Assertion 3: Complying with relevant laws and regulations

- The Council did not make proper arrangements for the approval of the accounts in line with the Accounts and Audit (Wales) Regulations 2014 and failed to approve the accounts by 30 June 2024.
- Section 50 of the Democracy and Boundary Commission Cymru etc. Act 2013 requires the Council to publish its audited accounts online. Regulation 5 of the Accounts and Audit (Wales) Regulations 2014 requires the Council to publish the Annual Governance Statement alongside the accounts. Regulation 15 of the 2014 Regulations requires the Council to publish along with the accounts, any certificate, opinion, or report issued, given or made by the Auditor General. The Council has failed to publish its qualified audit reports from previous years.

Assertion 4: Exercise of electors' rights

- The Council did not make proper arrangements for the exercise of electors' rights to inspect the accounts, as the Council's stated approval of the accounts on 17 October 2025 fell after the statutory inspection period.

Assertion 7 and 8:

- The Annual Governance Statement is incomplete as Assertion 7 and 8 were not answered.

Inconsistencies between Annual Governance Statement and Internal Audit report: The assertions made by the Council in its Annual Governance Statement are not consistent with the evidence presented in the Internal Audit report.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Notice of Completion of Audit

The Council does not publish on its website the information it is required to publish electronically by section 55 of the Democracy and Boundary Commission Cymru etc. Act 2013 and the Local Government and Elections (Wales) Act 2021.

We recommend that the Council publishes the Notice of Completion of Audit on its website each year.

Value for money

We note that the Council has not claimed VAT to which it may be entitled.

We recommend that the Council seeks to recover as much VAT as possible in order to strengthen its financial position and ensure value for money.

There are no further matters I wish to draw to the Council's attention.
